1. Introduction

All supporter benefits are provided on a best endeavours basis and may be updated, modified, substituted or improved over time.

Supporter memberships do not provide ownership, equity, voting rights, investment rights or financial interest in the vessel, expedition or Team Britannia Limited.

3. Member Communications and Updates

Supporter members may receive expedition updates, announcements and behind-the-scenes content via email, WhatsApp groups or other communication channels operated by Team Britannia Limited.

By purchasing a supporter membership, you agree to receive communications relevant to the Full Circle project and supporter experience.

Access to supporter communication groups is provided at the discretion of Team Britannia Limited and may be withdrawn in cases of abusive, disruptive, offensive or inappropriate behaviour.

We aim to provide regular updates where possible, however the frequency, format and availability of updates may vary depending on expedition activity and operational circumstances.

Team Britannia Limited is not responsible for outages, delays or interruptions caused by third-party communication platforms including WhatsApp or email providers.

4. Personalised Items and Delivery

Certificates and supporter materials are typically delivered digitally within 14 days of purchase, although timings may vary during periods of high demand, operational requirements or expedition activity.

Placement, appearance, format and positioning of supporter names on the vessel, Ship's Log or related materials may vary at the discretion of Team Britannia Limited.

Supporters acknowledge that some elements of the membership are personalised and commemorative in nature.

Supporters are responsible for ensuring that the spelling of submitted names and messages is accurate at the time of purchase.

5. Refunds and Cancellations

Supporter memberships are non-refundable.

By purchasing a supporter membership, you acknowledge that personalised and custom supporter materials, records and commemorative elements may begin processing shortly after purchase.

Because memberships include personalised and custom elements, cancellation and refund rights may not apply once processing has begun.

6. Expedition Disclaimer

The Full Circle expedition is an ambitious long-term project and may be affected by circumstances outside the reasonable control of Team Britannia Limited.

Routes, timings, destinations, schedules, launch dates and expedition plans may change, be delayed, postponed, shortened or cancelled due to factors including but not limited to:

- Weather conditions
- War or conflict
- Fuel availability
- Technical or mechanical issues
- Regulatory restrictions
- Sponsorship or operational challenges
- Global events or force majeure circumstances

Supporter memberships contribute to the wider project, vessel preparation and supporter experience and remain non-refundable regardless of expedition changes, delays, postponement or cancellation.

Nothing within the supporter membership constitutes a guarantee that the expedition will proceed exactly as described, within any particular timeframe, or at all.
